SUBMITTAL REQUIREMENTS

Submit plans to: CITY OF COLUMBIA DEVELOPMENT CENTER

Below are the plans necessary for review of an Addition to a Single Family Home or Duplex. Please note that incomplete plans will not be accepted for review. ALL PLANS MUST BE TO SCALE.

RESIDENTIAL NEW CONSTRUCTION/ADDITION PERMIT APPLICATION: 1 copy

CONTRACT (VERIFICATION OF JOB COST): 1 copy

D PLAN REVIEW FEE- \$25

SITE PLAN: 3 copies at 8 ¹/₂" x 11" Minimum

- Address(es) (if not yet assigned contact Engineering);
- Tax Map Sheet #s;
- Location of existing house and proposed addition showing setbacks from property lines;
- Show any other buildings on lot;
- North Arrow, Scale (not less than 1 inch equals 20 feet), and Vicinity Map (at 1 inch equals 1,000 feet);
- Lot coverage calculation: (a = total area in lot; b = area of building and structures on lot. Lot coverage = b divided by a).
- Driveways adjacent to and across from development.

BUILDING PLANS: 2 copies at 8 ¹/₂" x 11" Minimum

- Floor plan showing new addition and its connection to the house (list use of new space);
- Foundation detail including piers, lumber spans, grade beams for slab foundation;
- Show any and all changes to existing house;
- Flood Plain- sign statement on application form, and if applicable, include statement indicating relationship of proposed construction to the 100-year floodplain;
- Electrical outlets;
- Smoke detectors.

BUILDING ELEVATIONS: 2 copies at 8 1/2" x 11" minimum

- Detail exterior finish (brick, vinyl, etc.);
- Illustrate foundation construction.

□ ENERGY EFFICIENCY COMPLIANCE – 1 copy

- All projects will need to comply with the 2009 International Energy Code Sections which are referred to as the mandatory provisions and either: (A) the prescriptive approach; or (B) the performance approach.
