I. CALL TO ORDER - Chair Giovanetti

There being a quorum present, Chair Giovanetti called the meeting to order at 4:35 p.m.

II. REGULAR AGENDA

a. Approval of <u>January Meeting Minutes</u>

Ms. Leaphart made a motion to approve the January meeting minutes, and the motion was seconded by Mr. Cavanaugh. The minutes were approved by unanimous vote.

<u>February discussion notes</u> and <u>March discussion notes</u> were received as information, as they did not require a vote.

b. Review of draft Council Presentation re: Mayor's Request for BPAC Priorities

Members present briefly discussed the draft status of the presentation, and asked Ms. DeForth to resend the latest draft to the Committee as a whole in hopes of restarting that discussion.

c. City Planning Update

Ms. DeForth highlighted a few items in the Planning Update, encouraging members to participate in Bike Month events, including Bike to Work Day and the Midlands Ride of Silence. She noted that the Calhoun resurfacing and road diet project was out to bid. She indicated that she expected the percentage of locations counted during the Spring Pedestrian + Bicyclist Counts to drop, given that she was still waiting on nine outstanding responses, and had not had much luck with communication with those

volunteers. She briefly reviewed the Assembly Street Road Safety Audit and the River Drive Bridge Replacement, and noted that the ribbon cutting for the North Main project had occurred since BPAC last met. She also provided BPAC with an update on Blue Bike SC, and noted that the Bike Share Expansion Feasibility Study was nearing completion, and that the study could help inform the City's actions moving forward.

Mr. Giovanetti noted that he had recently reviewed updated plans for the Penny Shop Road Widening, and asked if staff had details on the planned Three Rivers Greenway bridge/extension that had been in the news

III. OTHER BUSINESS

Ms. DeForth indicated that City Council had reappointed Ms. Bynoe-Reed to BPAC, as her term had expired, but that no other appointments had been made. She noted that Ms. Jenkins, who handles appointments, had indicated that she had not received an application from Ms. Watson to be reappointed, and that due to Council's attendance policy, Ms. Watson was no longer eligible to serve under her prior term.
